Additional requirements	<p>Proposals (pre- and full proposals) must be submitted by the PI's host institution' administration (not by the PI) in electronic format to the FNR's grant management system no later than 5 working days after the JPND submission deadline.</p> <p>In addition, the following is needed:</p> <ol style="list-style-type: none">1) At both proposal stages 3 documents:<ul style="list-style-type: none">- INTER budget sheet,- INTER budget details (justification), and- INTER project plan

	<p>to be submitted by the Luxembourg PI to the FNR's grant management system, jointly with a pdf of the proposal submitted to JPND.</p> <p>2) Before start of the project:</p> <ul style="list-style-type: none"> - A consortium agreement (at least clarifying publication and IP rights) signed by all project partners. <p>The FNR will only accept a maximum of 2 JPND applications from an individual applicant.</p>
